4. Delinquent Members

Members who have not paid their **2005** annual dues are reminded that all those persons, whose dues are in arrears on **July 31, 2005**, will have their names placed on the **delinquent** membership list. They will cease to be eligible for membership privileges such as receiving copies of the 2005 Conference Proceedings and having their names published in the 2005 Conference Proceedings and Conference Program Booklet. Any member, whose dues for **2004 and 2005** remain unpaid on **July 31, 2005**, will be considered **suspended**; they will have their name removed from the membership list and will cease to be a member. Suspended members will also cease to receive CTAA mailings and their names will not be printed in the lists of members in the 2005 Conference Proceedings nor the Program Booklet.

5. CUPGA

As in previous years, the CUPGA session will be held on Sunday of the CTAA annual conference. An agenda is included with this newsletter. Please note that CUPGA registration fee is included on the CTAA Annual Conference registration form.

6. Proposed By Law Changes

The Board of Directors resolved at their mid-year Board meeting that certain changes be made to the By-Laws. Most of the suggested changes deal with housekeeping issues and uniformity. The Board is proposing that the year end be set back to June 30 from September 30 thus allowing more time for the auditors to review the finances and prepare their report.

The changes to the By Laws will be discussed at the Annual General Meeting on November 7, 2005, amended if necessary and then be passed to a letter ballot by a simple majority of the voting members present. The letter ballot will be conducted in January 2006.

The changes proposed are as follows:

Article 3

- 2. A Student Member shall be an individual who is a full time student at an institution of <u>post-secondary</u> learning whose interests include aspects of asphalt technology. <u>Upon completing a membership application formA a</u> Student <u>applicant Member shall be nominated by their university or college and becomes a Student Member upon following approval of the Board of Directors of the Association.</u>
- 3. A General Member shall be an individual who is experienced or interested in the characteristics and uses of asphalt materials. A General Member application shall provide an account of experience and interest in such form as may be required by the Board of Directors.

 <u>Upon completing a membership application formAan General Member</u> applicant becomes a General Member <u>upon-following approval</u> of the Board of Directors of the Association.
- 4. A Sustaining Member shall be an individual, firm, corporation, agency of Government, or other organization desiring to contribute greater support to the Association through the payment of higher dues. A Sustaining Member shall designate a representative. <u>Upon completing a membership application form a Sustaining member applicant</u> becomes a Sustaining member <u>upon following</u> approval of the Board of Directors of the Association.
- 5. An Honorary Member shall be an individual a member or past member of the Canadian Technical Asphalt Association who has performed distinguished services in the fields of activity related to the purposes of this Association, or who has rendered meritorious service to the same. An Honorary Member may must be nominated by any five Voting Members in good

standing. The nomination must be made in writing addressed to the Secretary-Treasurer and personally signed by the nominators or accompanied by personally signed letters. A nominee becomes an Honorary Member after approval of the Board of Directors of the Association, followed by and-ratification by the General Memmembership of the Association through a letter ballot.

- Election to membership shall be by majority vote of the Board of Directors.
- A rejected applicant shall not be reconsidered for Membership until at least one year after the previous application.
- 8.6.—All Members shall have all the rights and privileges as determined by these By-Laws and by the Board of Directors, properly constituted, except that a Student Member and Sustaining Member may neither vote nor hold office. General Members, and Honorary Members are considered Voting Members.
- 9-7. Any Member may be required to resign by a vote of three-quarters of the Voting Members at an Annual Meeting.
- 40-8. Notice of resignation from Membership or of change of a representative of a Sustaining member shall be presented in writing to the Secretary Treasurer, and thereby accepted.
- Article 4 4. Successive Directors shall be elected by letter ballot for a term of two years by the Members and announced at an—the Annual Meeting of its Members. A year is here construed as the period between the terminations of two successive Annual Meetings.
 - 10. Any remuneration of officers, agents, employees or committee members shall be fixed by the Board of Directors by resolution. Such resolution shall have force only until the next meeting of the Board Members—when such resolution shall again be confirmed by resolution of the Members—Board. In the absence of such confirmation the remuneration to such officers, agents, employees, or committee members shall thereafter cease to be payable.
- Article 7

 6. The Books of the Association shall be closed on the thirtieth day of <u>June September</u> of each year, and they shall be audited annually upon the direction of the Board of Directors. The Voting Members shall, at each Annual Meeting, appoint an Auditor to audit the accounts of the Association and to hold office until the next Annual Meeting, provided that the Directors may fill any casual vacancy in the office of the Auditor. The remuneration of the Auditor shall be fixed by the Board of Directors. The Auditor must be independent of the Association and its Members.
- Article 8
 6. All Members except Student Members and <u>Sustaining Members</u> shall be considered Voting Members and have equal voting rights at all meetings of the Association. All Directors, <u>with the exception of Board appointed Local Arrangements Committee Co-chairs</u>, shall have equal voting rights at all meetings of the Board of Directors. All voting resolutions of either body shall be carried by a simple majority unless otherwise required by these By-laws or applicable provisions of The Canada Corporations Act, as amended.
- Article 10 2. Election of a candidate to Membership is contingent upon payment of dues for the current year within thirty days of notification of election by the Secretary Treasurer to be submitted with the membership application.
