The Canadian Technical Asphalt Association invites paper proposals (Abstracts) for the 2017 CTAA Annual Conference. Proposed papers can be on any aspect of asphalt technology (materials, mixes, production, placing, compaction, design, monitoring, etc.) with the general requirements that the proposed paper not have been previously published in a similar form, be free of direct commercialism promoting products or practices from which the author could benefit, be properly prepared for the Proceedings, and be presented by the author (or one of the authors) at the conference, if selected. The abstracts will be judged on Significance (50%), Originality (35%) and Practical Nature (15%).

Please submit abstracts of about 500 words (or a draft of the proposed paper, if available) to the attention of the Conference Program Chair, Nabil Kamel, c/o #300 – 895 Fort Street, Victoria, BC V8W 1H7 or by email, admin@ctaa.ca or by fax to 250-361-9187. If your submission is being forwarded electronically, please ensure it is a **Word** file. *Submitters will receive a “Notice of Receipt of Abstract Submission” within 3 days of their abstract being received.* The Technical Program Committee will review all the abstracts received by **February 10, 2017**, and the authors of the papers selected will be notified by **March 3, 2017**. Authors must submit full papers to the Program Committee not later than **May 31, 2017**. A copyright release will be required to be signed by the author.

Please include the name, title, affiliation, address and telephone/fax number and e-mail address of each author (maximum of five) on the attached submission cover sheet and clearly indicate which author(s) will make the presentation, when submitting the abstracts.
