The 62<sup>nd</sup> Annual Conference, held in Halifax, NS, was attended by 279 delegates, plus 9 one-day delegates, 3 students. A total of 62 general new members have been mailed their membership certificates. The conference delegates, along with 34 accompanying persons, enjoyed the conference and local areas nearby the Halifax Marriott Harbourfront Hotel.

There were 21 technical papers presented at the conference. This year's CUPGA seminar on Sunday afternoon included brief presentations from CTAA's 6 Regional Directors as well as presentations and discussion on "Cutting Edge Innovations in Asphalt Technology". The technical papers covered a diverse set of topics from plant-derived modifiers to pavement structure calculations to colored asphalt. As well several papers on recycling and cracking brought case studies to the audience. If you were not able to attend the conference you should now (or very shortly) have received the bound proceedings, be sure to check out the technology presented. The technical papers are also available online via the member's area, just log in and select Workspaces\Proceedings Technical Papers and then select Technical Papers\2017. There is also the updated Index of Papers and the previously published compendium's now available there.

The training session, held on Sunday morning, for this year was entitled "An Introduction to Modified Asphalt Binders" and was widely received with 83 delegates registering to attend. The course was presented by Chris Lubbers and Charles J. Dubois and organized in conjunction with the Association of Modified Asphalt Producers. (Please take a moment to thank the presenters if you get a chance, it is through volunteers like these that we have been able to continue to offer interesting courses to the membership for the last 10 years). The course covered chemical modifiers, polymer modifiers, crumb rubber and engineered binders as well as testing and rheology considerations and on-site handling of these special binders.

The success and continued existence of the Association depends on the presentation of sufficient high quality technical papers at our conference.

# **UDDATES AND TIDBITS**

#### **Newest Honorary Member—2017**

On November 14, 2018, Keith MacInnis was made an honorary member of CTAA.

Keith MacInnis is a native Nova Scotian who began his university education at Acadia University where he graduated as a university medalist with a Bachelor of Science (Honours in Chemistry). He was awarded a Ph.D. in Organic Chemistry in 1982 from McMaster University. He then moved to the University of Toronto for a post-doctoral fellowship with Professor James Guillet investigating polymer photochemistry.

Fortunately Professor Guillet had an entrepreneurial spirit which afforded Keith the opportunity to work for two of his start-up companies. The first company specialized in photodegradable plastic while the second start-up endeavoured to commercialize a technology, invented by Professor Guillet, which used polymer beads as reaction vessels for photochemical reactions.

After this introduction to industrial chemistry, Keith made the transition to the asphalt industry which was a real eye opener. He had to become acquainted with the black art of asphalt technology. As research director at McAsphalt Industries he was fortunate to have worked alongside Dr. Norman McLeod and Keith Davidson.

Keith moved on to join Canadian Asphalt Industries as Senior Technical Advisor where he has been for over twenty years. He is indebted to Ray Legault and Bruce Armstrong who gave him the latitude and encouragement to work on a variety of OHMPA (now OAPC) committees, present the opening lecture at OGRA's Scott McKay Technology Course and to remain involved with CTAA.

CTAA has been an integral part of Keith's career. He has coauthored five papers and authored a response to a CTAA paper which is to be submitted for publication in the 2017 proceedings. Currently, CTAA is preparing an online textbook on hot mix asphalt focusing on materials and mix designs used in Canada. The project is directed by Professor Alan Carter (ÉTS), the 2015 CTAA president. Keith's role is to write the chapter on asphalt cement.

Not just an author but also a presenter, Keith won the Norman W. McLeod Award for best presentation at the 1991 CTAA conference in Montreal. Also interested in the operations of the association, he served two terms as the Ontario director and then held the office of President in 2014.

Keith's involvement in the industry also included participation with the Ontario Good Roads Association. In 2016 this organization recognized his contributions to the Municipal Infrastructure Training Courses with a long term service award.

Although Keith has recently returned to Nova Scotia, he still continues to act as Senior Technical Advisor for Canadian Asphalt Industries. He maintains his membership on the OAPC technical committee. Keith looks forward to many more years of participation in CTAA as an active member, conference attendee and author.

#### Available CTAA Scholarships

Provided qualified applications are received, CTAA, in 2018, plans to again award 3 scholarships each valued at \$2000.00; the CTAA Graduate Scholarship, the CTAA Undergraduate Scholarship and the CTAA Applied Technology Scholarship.

The CTAA Graduate Scholarship will be presented to a student who has been admitted into, or is currently enrolled in, a Canadian university program leading to a post graduate degree which contributes to advances in any facet of asphalt technology. Eligible fields of study include chemistry, chemical engineering, and construction or civil engineering. Other areas of study may be considered provided the applicant clearly notes the relevance of his/her curriculum towards asphalt technology.

The CTAA Undergraduate Scholarship will be presented to a student who has been admitted into, or is currently enrolled in, a Canadian technical college or a university program leading to an undergraduate degree which contributes to advances in any facet of asphalt technology. Eligible fields of study include chemistry, chemical engineering, and construction or civil engineering. Other areas of study may be considered provided the applicant clearly notes the

relevance of his/her curriculum towards asphalt technology.

The CTAA Applied Technology Scholarship will be presented to a student who has been admitted into, or is currently enrolled in, Canadian technical college or a community college program leading to a diploma which contributes to advances in any facet of asphalt technology. Eligible fields of study include chemistry, chemical engineering, and construction or civil engineering. Other areas of study may be considered provided the applicant clearly notes the relevance of his/her curriculum towards asphalt technology. Applicants with industrial experience in asphalt technology are encouraged to

Application Process: In order to be considered for the annual CTAA Scholarships the following materials must be received by the CTAA office no later than July 1st. Information received after this deadline will not be considered in the scholarship

review process.

- Completed scholarship form;
- Applicant's resume (outline education, career objectives, work experience, community involvement, participation in extracurricular activities, special interests and achievements);
- Current academic transcripts;
- Applicant's statement of present and long-term career goals and aspirations (500 words or less);
- Three reference letters as noted below:
  - A letter of reference from the applicant's program advisor.
  - Two reference letters, preferably from CTAA members, or from individuals knowledgeable in the technical/academic qualifications of the applicant.
- The original letters must be sent directly to the CTAA office.

Members of the Canadian Technical Asphalt Association are encouraged to pass on this information to students that may be interested in our scholarship program and who may not be aware of the information we pass on to institutions of higher learning. The Board of Directors has attempted to identify all the institutions in Canada and a particular individual in each institution but some may have been missed and they look to the members for assistance.
