CAREER

Chris started out as a material testing technician for what was AMEC Earth and Environmental. In 2010, joined the City of Regina and has had four different roles in that time.

Most notably for CTAA would be:

- Supervisor, Testing Lab, and Materials Engineering – Supervise lab technologists and technicians for materials testing and roadway construction inspection; design various asphalt mixes, sand/salt mixes, provide roadway technical suggestions and recommendations for construction and design; make asphalt plant adjustment to the asphalt mix as required to ensure performance.
- Manager, Asphalt Production and Materials Engineering - Manage, lead, and direct the Asphalt Production and Materials Engineering Branch with respect to asphalt production, materials manufacturing, recycled materials sales, materials testing and engineering, managing city assets such as the asphalt plant, screening and blending equipment, gravel pits, testing laboratory equipment, and the yard scale.
- Manager, Roadways Capital Operations - Responsible for the management of the Roadways Capital Operations Branch within the Department of Roadways and Transportation, including operational and program planning, stakeholder relationship management, financial management and people leadership.

Mandate includes management of the City's Capital construction crews (concrete placement, alley reconstruction, asphalt milling and paving), infrastructure reconstruction, accompanying landscaping, asphalt production and seasonal material handling, recycled materials sales, managing city assets such as the asphalt plant, screening and blending equipment, gravel pits and Materials Testing Lab and inspection.
